Milestone Ranch MX Park Membership Form

Membership is required to ride and is valid for 1 year from registration date. The annual membership fee is \$35. The daily ride fee is \$25 (for Pee Wee the daily fee is \$20 & for R/C Cars the daily fee is \$10). Riders may receive a discount on the daily ride fee by purchasing a 4 for 5 pass (pay for 4 rides and get 1 FREE) or an annual pass. Military/Police/Fire discount is \$5 off membership and daily ride fee. Overnight camping fee is \$20, weekend camping fee is \$35. Replacement cards \$10. You must have your card present each time you ride at the park. The membership is not transferable or refundable.

RISK FACTORS** The undersigned understands and acknowledges that ATV and Motorcycles are an inherently dangerous activity and involves risks such as, but not limited to, the following which might result from the use of equipment or facilities, from the activity itself, from the acts of others, or from the unavailability of emergency or emergency medical care: RISK OF PROPERTY DAMAGE, BODILY INJURY, AND POSSIBLE DEATH. **56143. ASSUMPTION OF RISK** The undersigned ASSUMES ALL RISKS THAT ARISE OUT OF THE USE OF THE EQUIPMENT OR FACILITIES, THE ACTIVITY ITSELF, THE ACT OF OTHERS, OR THE UNAVAILABILITY OF EMERGENCY CARE, including but not limited to, those RISK FACTORS described in section 1 above. **56144. ACKNOWLEDGEMENT OF POLICIES AND PROCEDURES** The undersigned acknowledges reading and knowing all of the policies and procedures relating to the activities, facilities, and/or equipment and understands that the safe and proper use of the facilities, equipment or participation in the activity is dependent upon carefully following such policies and procedures. **56145. PREREQUISITE SKILLS AND TRAINING** The undersigned acknowledges that he or she has the requisite skills, qualifications, physical abilities, and training necessary for proper and safe use of the equipment and facilities and to participate in the activity itself. The undersigned agrees that if he or she has any questions as to what skills, qualifications or training is necessary to properly use the equipment, facility, or to participate in the activity itself, then they shall direct such questions to the appropriate staff member on site. **56146. This means, in part, that the undersigned is releasing unknown future claims. **56148. INDEMNIFY AND DEFEND** The undersigned agrees to INDEMNIFY AND DEFEND Milestone Ranch MX Park Inc., its officers, employees and agents, and hold them harmless from any or all claims, causes of action, damage judgments, costs or expenses, including attorney fees which in any way arise from the activity or this agreement which include but are not limited to damages to or destruction of any property of the indemnities, of any others, injury or death of the undersigned or anyone else or any liability arising from the act or negligent act of the indemnities, the undersigned or anyone else. **56149. PAY** The undersigned agrees to pay for any or all damages to any property or indemnities caused by the undersigned either negligently, willfully, or otherwise. **56150. REPRESENTATIVES** The undersigned enters into this agreement for himself/herself, his/her heirs, assigns and legal representatives. **56151. EMERGENCY TREATMENT CONSENT** The undersigned, as a participant in the subject activity, hereby consents to medical treatment in a medical emergency where the undersigned is unable to consent to such treatment. **56152. INSURANCE** The undersigned understands that the Milestone Ranch MX Park, Inc. does not carry participant insurance.
